

#### **Banning Distilled Alcohol Advertising**

WHEREAS	NRB realizes the power of broadcasting for good and for ill, and
WHEREAS	NRB recognizes the power of advertising to affect behavior and lifestyle choices, and
WHEREAS	Irresponsible choices can have damaging and deadly consequences, and
WHEREAS	Children can be influenced to make dangerous decisions through the power of television. Therefore, be it
RESOLVED	That the NRB urges the major television networks, particularly NBC, to reinstate its ban on spots for distilled spirits and hard liquor. An intoxicated person somewhere is a threat to people everywhere. We invite all broadcasters to join us in an effort to serve the public through responsible advertising.



### **Supporting The Ban On Human Cloning**

WHEREAS	NRB recognizes that God is the Author and Creator of life, and
WHEREAS	NRB recognizes that we are "fearfully and wonderfully made" (Psalm 139:14), and
WHEREAS	We know that we have been created and "knit together in our mother's womb" (Psalm 139:13b), and
WHEREAS	Those who know the Giver of life must not be silent on issues of life, and
WHEREAS	NRB knows the power of the air waves to influence our culture for good instead of evil, and
WHEREAS	Our Congress is currently dealing with one of the most important life issues in the history of our nation, and
WHEREAS	Human beings should not be created and destroyed under the guise of giving medical benefits to someone else. Therefore, be it
RESOLVED	That the NRB urges the Congress and the President of the United States to stand in strong opposition to the cloning of human beings. We further urge all broadcasters to use whatever medium has been afforded them to influence the culture that a ban must be put in place to prevent the cloning of human beings.



#### **EEO Rules**

WHEREAS	NRB overwhelmingly endorses the concept of equal opportunity in employment, and
WHEREAS	the past the FCC has enacted various EEO rules to be followed by radio and television stations, and
WHEREAS	Two previous sets of EEO rules were struck down by the DC Circuit Court, and
WHEREAS	The FCC now prepares to adopt new EEO rules similar to Option A under the previous rules, and
WHEREAS	While we generally oppose any new EEO rules, NRB believes some aspects of these proposed rules would be overly burdensome and expensive, especially to smaller stations with few, if any, desirable results. <i>Therefore, be it</i>
RESOLVED	<ul> <li>While we oppose any new EEO rules, that the NRB requests the FCC to include the following provisions in any new EEO rules:</li> <li>a. The FCC should not require recruitment for every job.</li> <li>b. The EEO mandate should focus on outreach.</li> <li>c. The FCC should adopt an outreach rule that gives stations a menu of options to meet EEO requirements.</li> <li>d. The EEO should not be connected to license review.</li> <li>e. Stations could comply by: <ul> <li>i. Participating in BEDA careers programs</li> <li>ii. Complying with OFCCP affirmative action rules, or</li> <li>iii. Undertaking a mix of outreach initiatives (job fairs, scholarships, on-air announcements, contacts with minority and female organizations, etc.)</li> </ul> </li> <li>f. No annual employment report.</li> <li>g. Stations would certify compliance every four years, but not be required to submit records or include information in the public file or on the Web site.</li> <li>h. Stations in communities with less than five percent minority population would be exempt.</li> <li>i. Stations with 10 or fewer full-time employees would be</li> </ul>
	exempt.



#### **The Fairness Doctrine**

WHEREAS	The so-called Fairness Doctrine is a very real threat to all Christian broadcasters, and
WHEREAS	In the past, religious broadcasters often were singled out as targets of Fairness Doctrine enforcement efforts, and
WHEREAS	There is no existing statutory provision that would preclude the FCC from re- enacting such a policy at any time, and
WHEREAS	While there is no realistic threat of such FCC action in the near future, it is desirable (at a politically opportune moment) to seek protective legislation, and
WHEREAS	After the 2002 election it would be appropriate to assess whether the time might be right for such a legislative initiative. Therefore, be it
RESOLVED	That the NRB will immediately begin the process of informing friendly public officials of the importance of this matter to religious broadcasters and work toward a statutory provision that, hopefully, forever will preclude the FCC from re-enacting the Fairness Doctrine.



### **Record Industry Artist Association (RIAA)**

WHEREAS	The RIAA has proposed unreasonable license fees on the streaming of recorded music, including Christian music, and
WHEREAS	This rate issue is now being negotiated and litigated, and
WHEREAS	The proposed unreasonable rates, if allowed to stand, will make it nearly impossible to stream recorded Christian music. Therefore, be it
RESOLVED	That the NRB will work vigorously through all avenues available to achieve fairness for music streaming on the Internet, utilizing negotiation, the judiciary and the legislature.



### Satellite Digital Audio Radio Services (SDARS)

WHEREAS	SDARS is now operating and offering few faith-based channels and seeks to compete with NRB terrestrial broadcasters, and
WHEREAS	SDARS operators seek almost unrestricted options in operation of "boosters." Therefore, be it
RESOLVED	That the NRB goes on record as asking the FCC to make permanent the STA provisions that "SDARS repeaters are restricted to the simultaneous retransmission of the complete programming; and only text programming, transmitted by the satellite directly to the SDARS subscribers' receivers."



### **Supporting Israel**

WHEREAS	The State of Israel is a sovereign nation, as recognized by the United Nations, and
WHEREAS	Israel is a democracy, governed by the expressed will of its people, and
WHEREAS	Any nation has a right to defend itself against foreign powers and the threat of terrorism, and
WHEREAS	Israel has been forced to fight for its existence and protection since its founding in 1948, and
WHEREAS	We are commanded in Scripture to "pray for the peace of Jerusalem" (Psalm 122:6). Therefore, be it
RESOLVED	That the NRB expresses its support for the State of Israel's right to exist, right to defend itself and right to peaceful respect, and be it
RESOLVED	That the NRB calls upon all persons and parties to renounce terrorism in any form, and be it further
RESOLVED	That the NRB calls upon all persons to pray for the peace of Jerusalem, and to seek a true and just peace respecting all persons.



### True, Fair And Equal Access

WHEREAS	Real openness of the airwaves creates a true marketplace of ideas, and
WHEREAS	The explosion of new technologies, such as satellite television and satellite radio, has created greater opportunities for equal access for broadcasters, and
WHEREAS	The scales of programming continue to be tipped toward vulgar, lewd, sexual and indecent content, and
WHEREAS	A real balance can only be achieved by allowing religious broadcasters the same and equal access to all broadcasting outlets. Therefore, be it
RESOLVED	That the National Religious Broadcasters (NRB), at its 59 <sup>th</sup> Annual Convention in Nashville, TN, petitions all media outlets, including new mergers and acquisitions, to provide true, fair and equal access to the airwaves for religious broadcasters.
